

RESOLUTION

The following Resolution was duly adopted by the Board of Directors of Prairie Lakes Area Education Agency, after appropriate motion and second, at the public hearing and open meeting held on May 17, 2022, at 5:00 PM in the Algona Community School District, 600 South Hale Street, Algona, Iowa 50511.

WHEREAS, a Petition was filed with the Board of Directors of Prairie Lakes Area Education Agency pursuant to Iowa Code Section 275.12 to merge the Algona Community School District and the Lu Verne Community School District into a new Community School District to be known as the Algona Community School District; and

WHEREAS, the Petition and the proposed boundary line for the new school district have been reviewed by legal counsel and found by counsel to be in accordance with the requirements of Iowa Code Section 275.12; and

WHEREAS, pursuant to Iowa Code Section 275.14, the Chief Administrator of Prairie Lakes Area Education Agency fixed the final date for filing objections to the Petition on May 9, 2022, and has fixed the date for a hearing on the Petition and on objections to Petition for today, May 17, 2022, at 5:00 PM in the Algona Community School District, 600 South Hale Street, Algona, Iowa, and thereafter has caused publication of a notice of said hearing and final date for filing objections according to law; and

WHEREAS, the studies and surveys conducted by this Board pursuant to Iowa Code Chapter 275 have been updated and its plan under said Chapter having been amended;

WHEREAS, Prairie Lakes Area Education Agency Board of Directors has reviewed its studies, surveys, and plan and determined that the Petition complies with the plan which has been adopted by the Board;

WHEREAS, no objections to the Petition have been filed on or before 12:00 noon on May 9, 2022;

WHEREAS, said public hearing has been held according to Iowa Code Section 275.15 and all interested parties having presented evidence and arguments, and the matter of the Petition having been considered by the Prairie Lakes Area Education Agency Board of Directors on its merits; therefore be it

RESOLVED, that the Petition for Reorganization for the Agona Community School District and the Lu Verne Community School District into a new Community School District to be known as the Algona Community School District to be effective July 1, 2023, a true copy of said Petition being attached to this Resolution, is hereby approved for presentation at a special election

according to law, and the boundaries of the proposed Algona Community School District are hereby fixed as described in Exhibit "A" to said Petition, all as being in the best interests of all parties concerned, having due regard for the welfare of adjoining Districts.

RESOLVED FURTHER, that the number and method of election of the Directors of the Algona Community School District shall be as set forth in said Petition.

RESOLVED FURTHER, that the entirety of the assets and liabilities of the two Districts shall become the assets and liabilities of the Algona Community School District effective July 1, 2023 with exceptions as set forth in the Petition.

RESOLVED FURTHER, that the Chief Administrator of the Prairie Lakes Area Education Agency shall publish this Board's decision pursuant to Iowa Code Section 275.15 and shall perform all other acts required of her or of the Agency pursuant to Chapter 275 of the Code of Iowa.
